Volunteers stay with a child through multiple placements and difficult transitions. Further, they become the eyes and ears of the judge who will make critical decisions regarding the child.

With the generous support of our community, we provide an effective program with high quality training, management and accountability. We are proud of our program and the caliber of volunteers we attract, but we need to help to ensure we reach every child who needs an advocate. Last year we served 475 foster children and 35 families in Placer County with your generous support!
